The C1/D visa is a combination visa issued by the United States for crew members who work on international commercial airlines or sea vessels. It allows crew members to transit through or visit the United States for short periods, typically while their aircraft or vessel is in a U.S. port or airport.

Media (I) visas are for representatives of the foreign media, including members of the press, radio, film, and print industries. Activities in the United States must be for a media organization having its home office in a foreign country and should be generally associated with the news gathering process and reporting on current events.

## Bank Deposit option (Cash or Electronic Transfer (EFT)):

When accessing this payment option, you must generate and download a payment deposit slip by clicking on the GENERATE button accessible on the screen. Follow the instructions on the deposit slip to make a cash payment at the bank or EFT payment through online banking. These payments are to be made in local currency only.

After making a payment via Cash or EFT, please allow one business day for the bank to process the transaction before continuing to the appointment calendar to book an appointment.

There is no wait time for the transaction to be processed. 

#### U.S. Visa Application Fees

#### Non-Refundable Application Fees:

All paid U.S. visa application fees are non-refundable. The application fee is a requirement for applicants to APPLY for a U.S. visa; however, it does not guarantee that a U.S. visa will be granted. Once payment is made, the application fee cannot be refunded. If you believe there has been an error, please contact our call center for further assistance.

#### Non-Transferable Application Fees:

U.S. visa application fees are specific to the country where the visa application is submitted. These fees cannot be transferred or used for applications in another country.

#### Validity Period:

U.S. visa application fees are valid for scheduling within one year from the date of payment. After one year, any unused fees will expire and will not be refunded.

#### Chargebacks:

If you pay your U.S. visa application fee by card and initiate a chargeback dispute, this action may impact your current visa application status and any future visa requests.




